also help to them to fulfil their basic needs as well as help develop them into self-confident and

## Food:-

The food will be provided for all residents according to their health and their habits and there will be chance given to the resident to select their favourite food. Furthermore, all the food menu will be monitored by a dietician.

## **Quality food schedule:-**

6.00 - 6.30: Tea, Coffee or hot milk

7.30 – 8.30 : Breakfast will be in the following category

Bread with batter, jam, egg

Milk, cornflake in different variety

Idly, Dosai, Paddani kadalai

And coffee, tea, orange

10.00 – 10.30 : Seasonal fruits and coffee, tea, lassy, king coconut

12.00 – 13.00 : Lunch will be in the following category

Good quality rice and three different types of vegetable curry, meat (except beef and fork)

Fish, egg curry and egg fry, curd, payasam

And fruit juice, banana, seasonal fruits.

15.00 - 15.30 : Sort eats - vadai, sweet, Snacks and coffee, tea

18.00 – 19.30: Diner will be in the following category

Good quality bread, soups in different variety

Pittu, string hoppers, uppumaa, rotti, sappaathi, noodles

21.00 - 22.00 : Bed time - hot milk, vitamins

Special menu will be given on festival days, birth days and resident's special days.





## **Cost Incurred**

According to the administration regulations of "Poojahaham", the person who wishes to reside at "Poojahaham"/ the guarantor needs to fulfil the following financial related responsibilities:

1. You should pay the following amount for food, services, amenities, facilities, care and other expenditure:

**Monthly 220 CHF** (Two hundred and twenty Swiss franks) per person

According to the financial status of resident or guardian, this payment may be differing.

This amount should be paid before 5<sup>th</sup> of every month in English calendar.

*Note:* If a person lost his / her life partner whilst staying at Poojahaham, they will be transferred to another room or will share the room with another person in order to reduce the depression of a lost loved one.

2. The following amount should be paid by the resident as a **secured deposit** and this amount will be used for immediate medical treatment for the resident or penalty for the assets damages done by the resident. This amount should be paid immediately by the guarantor:

400 CHF (Four Hundred Swiss Frank) per person.

3. The relationship between the staff of Poojahaham and the guardians of the residents

The guardians of the residents are not allowed to have personal contact with the staff of Poojahaham, under

any circumstances.

A breach of this term will enable Poojahaham's management to terminate the contract and take legal action.

All legal costs will be paid by the guardian of the resident in question.

If the Guardians of the residents wish to do any special services for His/her relative has to contact the Management only.

*Note:* There is no interest paid for the secured deposit and the secured money will be repaid as following conditions.

- a) If the resident left on his / her own decision or passes away after staying less than a 6 months period, Then 50% of the secured deposit will be repaid to him / her after one month.
- b) If the resident left or passes away after a 6 month period from Poojahaham, Then 75% of the secured deposit will be repaid to him / her after one month.
- c) If the administration committee finds any misconduct done by a resident, then the administration of Poojahaham may ask the resident to vacate the place. In this situation after one month 75% of the secured deposit will be repaid to the resident without considering the period of stay. Furthermore, all the deductions, which are needed to be paid by the resident will be claimed from the secured deposit.
- d) If the resident wants to vacate the home he/she have to give one month notice or one month payment has to pay.
